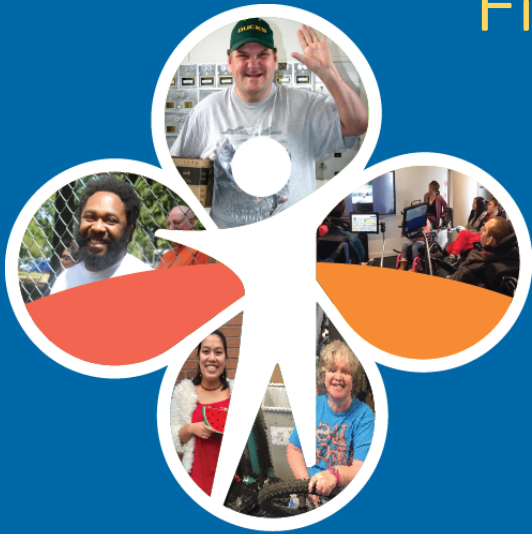

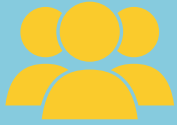

A young woman, Katelyn, came into our Open Lab Hours. She has Spinal Muscular Atrophy, which leaves her with only small movement in her fingers. She wanted to be able to control her iPad so that she could make and receive calls without her family having to help. We set her up with a switch control, and she was able to make a call. After her visit, we coordinated a trial with the equipment so she could try it at home. Then, we learned that a donor had covered the cost of Katelyn's equipment! She is currently using her new-found freedom to enhance her communication.

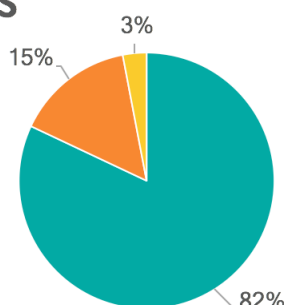

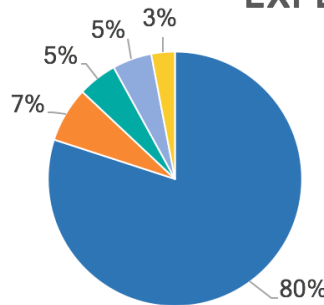
